Dear Sir,

The important issues/developments related to the Department of Water Resources, River Development & Ganga Rejuvenation during the month of February 2023 are as follows: -

- A. Storage Position of Important Reservoirs (CWC): The Central Water Commission (CWC) is monitoring live storage of 143 important reservoirs spread all over the country and issuing bulletin on every Thursday. Live storage in these reservoirs as on 23.02.2023 was 96.592 billion cubic meters (BCM), which is 94% of the live storage of corresponding period of last year and 118% of storage of average of last ten years.
- **B. DHARA 2023**: On 13th and 14th February 2023, National Mission for Clean Ganga (NMCG) in collaboration with National Institute of Urban Affairs organized "DHARA 2023: Driving Holistic Action for Urban Rivers" in Pune, Maharashtra. Hon'ble Minister of Jal Shakti inaugurated the conference attended by 51 Municipal Commissioners/Additional Commissioners of member cities of the River Cities Alliance. Issues related to river management were deliberated upon in the two day conference.

C. National Mission for Clean Ganga (NMCG):

- Executive Committee Meeting: In the 47th Meeting of the Executive Committee of NMCG held under the chairmanship of DG, NMCG on 22nd February, 2023, 9 projects worth Rs. 1,278 crore were approved, including 7 projects pertaining to pollution abatement in the Ganga Basin and 2 relating to ghat development. A novel project of Rs. 1.9 crore called "Survey, Investigation for Rejuvenation and Conservation of Shahdara Drain with nature-based treatment" was also approved.
- **World Wetlands Day**: On 2nd February, 2023, NMCG along with World Wide Fund for Nature-India (WWF-India) celebrated the World Wetlands Day at Sheesh Mahal (Irrigation Department, UP), Narora Barrage, Upper Ganga Ramsar site. DG, NMCG along with Biodiversity Consultant, NMCG attended the event. During the event, DG, NMCG also inspected the 100 acre biodiversity park at Ram Ghat and the Turtle Rescue Center at Anu Vihar, Narora Atomic Power Stations (NAPS) residential colony.
- Uttar Pradesh Global Investors Summit (UPGIS) 2023: On 10th February, DG NMCG visited Lucknow to attend the Uttar Pradesh Global Investors Summit (UPGIS) 2023 held from 10-12 February 2023 at Lucknow and participated in session on "Tourism: leveraging the cultural heritage for tourism in the modern progressive Uttar Pradesh".

• Sustainable Water Management Conclave: On 3rd February, 2023, NMCG in association with APAC News Network organized the 7th Water Management Conclave on the theme "Awareness to Technology Adoption - Sustainability in Water Waste Water Sector" at New Delhi.

Project Site Visits:

- i) CETP at Jajmau & Rooma, Kanpur: On 1st February 2023, Executive Director (Technical), NMCG visited Kanpur for the inspection of the 20 MLD CETP at Jajmau, 1.5 MLD CETP and 20 KLD TADOX pilot plant at Rooma.
- **ii) STP & CETP at Rooma and Jajmau, Kanpur**: On 17th February 2023, DG, NMCG along with ED (Technical), NMCG visited Kanpur to inspect 130 MLD STP and 20 MLD CETP plant at Jajmau. DG, NMCG also inaugurated the trial run of 20 KLD TADOX pilot plant at 1.5 MLD CETP Complex, Rooma, Kanpur.

- **iv) STP and Pond Rejuvenation projects at Ayodhya**: On 28th February, 2023 DG, NMCG along with representatives of UPJN visited Ayodhya to review the progress of work in the STP, water bodies and pond rejuvenation and review the status of the projects under Namami Gange Programme.

- A delegation led by Secretary (WR) attended the meeting of the Neutral Expert appointed under the Indus Waters Treaty to discuss issues relating to Kishenganga and Ratle hydro-electric projects with India and Pakistan called on 27 – 28 February, 2023 at The Hague, Netherlands.

- As a part of the NAQUIM studies, during the month of February 2023, CGWB has constructed 05 high discharge wells - 1 each in the States of Odisha, Gujarat, Andhra Pradesh, Kerala and Chhattisgarh.
- 04 Public Interaction Programs (PIP) under Azadi ka Amrit Mahotsava were organized in States of Kerala, J&K and Chhattisgarh by CGWB.

H. National Water Mission (NWM):

- 37th National Water Mission webinar session on "Best Practices of Water Management – Dialogues with District and Municipal Administrator" was held under the chairpersonship of AS & MD, NWM on 04.02,2023.
- 44th Water Talk entitled "Water Literacy" was delivered by Mr. Ayyappa Masagi, Founder & Director, Water Literacy on 24.02.2023.

 Meeting of the Selection and Screening Committee was held under the chairpersonship of Additional Secretary & Mission Director, National Water Mission on 21.02.23 for selection of women achievers for the event "Swachh Sujal Shakti Samman (SSSS), 2023 under the category Jal Shakti Abhiyan- Catch the Rain and Water Warriors.

J. Increasing efficiency in decision making:

- As per the latest edition of Central Secretariat Manual of Office Procedure (CSMOP), the channel of submission has been reduced to four levels by issuing departmental instructions. It has been observed that the Desk Officer System is not suitable for adoption in this Department, considering its allocation of work. The Department has adopted e-Office from February 2017 and is presently using the version 7.2.1. The Central Registry Unit has been digitized.
